16	Interurban Trucks category of automobile insurance; and

18	WHEREAS the IAO filing option may be used by insurers to adopt the most recent IAO rating
19	program accepted for use by the Board; and

21	WHEREAS the IAO filing option may also be used to introduce deviations to the IAO rating
22	program by insurers that are proposing to adopt or are currently using IAO rates; and
23	
24	WHEREAS Chubb Insurance Company of Canada proposed to adopt the IAO rates for
25	Commercial Vehicles and Interurban Trucks accepted for use by the Board in Information Bulletin
26	A.I. 2020-06 issued on May 5, 2020; and

28	WHEREAS no deviations to the IAO rating program are proposed; and

30	WHEREAS Chubb Insurance Company of Canada does not have sufficient company loss
31	experience to prepare an independent actuarially based filing; and
32	WHERE A C. A.
33	WHEREAS the revised rating program is consistent with the IAO Filing Guidelines and is

supported; and

WHEREAS the Board is satisfied that the proposed rates are just and reasonable in the circumstances, do not impair the solvency of the insurer, are not excessive in relation to the financial circumstances of the insurer, and do not violate the Automobile Insurance Act or the Insurance Companies Act or the respective regulations thereunder.
