

PETROLEUM PRODUCTS PRICING REVIEW HIGHLIGHTS FOR ISLAND CONSUMERS AND INDUSTRY

BOARD REQUESTS ADDITIONAL INFORMATION AND COMMENTARY

The Board is seeking additional information and commentary from consumers and industry on the Island as part of its ongoing review of petroleum products pricing regulation in the province. A separate process will be followed for Labrador consumers and industry in the coming weeks.

A significant amount of information has been gathered and analyzed by the Board and its consultants throughout this review and a number of potential changes have been identified. The Board is now inviting consumers and industry to provide their views and further information on these potential changes before the Board makes its determinations.

POTENTIAL CHANGES BEING CONSIDERED

The potential changes being considered by the Board would, if implemented, impact maximum prices on the Island as well as the processes used by the Board for establishing these prices.

- Potential Increases in Maximum Prices -

Based on the information gathered to date wholesale and retail supply costs have increased in recent years. If it is determined that these cost changes should be reflected in the mark-ups and zone differentials, maximum prices for regulated petroleum products in the province may increase. It is estimated that maximum prices in the base zone could increase by 0.7 cents per litre for regular gasoline, 1.6 cents per litre for diesel motor fuel and 4.3 cents per litre for furnace oil. The attached tables set out the estimated impact of potential mark-up and zone differential changes for all areas of the Island.

- Other Potential Changes -

Other identified changes being considered, include:

- Moving the weekly adjustment to Friday to be consistent with other Atlantic provinces;
- o a new way of calculating benchmark prices to better reflect product cost;
- furnace oil blending methodology changes to better reflect seasonal changes in the product;
- o reducing the number of pricing zones in the province to simplify pricing;
- o discontinuing the pricing of stove oil heating fuel on the Island based on sales volumes; and,
- more frequent reviews in the future of wholesale and retail cost changes to promote efficient and effective price regulation.



In addition, the Board may recommend legislative amendments regarding benchmarking for higher grades of gasoline motor fuel and to provide more discretion for the Board in establishing maximum prices.
