1 **IN THE MATTER OF** the *Petroleum*  
2 *Products Act*, SNL 2001, Chapter P-10.1  
3 (the “*Act*”) and regulations thereunder;

6 **IN THE MATTER OF** the suspension of  
7 maximum price adjustments for gasoline  
8 and diesel motor fuels and stove oil heating  
9 fuel in Zones 10, 11, 11a, 11b, 12 and 14.

12 **WHEREAS** Order No. P.P. 25(2021) suspended maximum price adjustments for gasoline and  
13 diesel motor fuels and stove oil heating fuel in Zones 10, 11, 11a, 11b, 12 and 14, effective June  
14 10, 2021; and

16 **WHEREAS** based on delivery information provided to the Board by suppliers to the region the  
17 winter resupply of gasoline and diesel motor fuels and stove oil heating fuel to Zones 10, 11, 11a,  
18 11b, 12 and 14 has commenced and will soon be completed; and

20 **WHEREAS** the Board is satisfied that maximum wholesale and retail prices in Zones 10, 11, 11a,  
21 11b, 12 and 14 should be adjusted to reflect the winter supply of gasoline and diesel motor fuels  
22 and stove oil heating fuel; and


24 **WHEREAS** the Board is satisfied that the seasonal suspension of maximum price adjustments  
25 should be implemented for gasoline and diesel motor fuels and stove oil heating fuel in Zones 10,  
26 11, 11a, 11b, 12 and 14.

- 31 1. The suspension of maximum price adjustments for gasoline and diesel motor fuels and  
32 stove oil heating fuel implemented pursuant to Order No. P.P. 25(2021) is lifted, effective  
33 12:01 a.m. November 25, 2021.

- 1 2. Maximum price adjustments in Zones 10, 11, 11a, 11b, 12 and 14 shall be suspended as of  
2 12:01 a.m. November 25, 2021 for gasoline and diesel motor fuels and stove oil heating  
3 fuel, until further order of the Board.
