1 **IN THE MATTER OF** the **Petroleum Products**  
2 **Act**, SNL 2001, Chapter P-10.1 and regulations  
3 thereunder; and

5 **IN THE MATTER OF** the setting of maximum  
6 prices to be charged for gasoline motor fuel in  
7 Zones 10, 11, and 11b; and

9 **IN THE MATTER OF** the lifting of the current  
10 suspension of maximum price adjustments for  
11 gasoline motor fuel in Zones 10, 11 and 11b;

14 **IN THE MATTER OF** the suspension of  
15 maximum price adjustments for gasoline motor  
16 fuel in Zones 10, 11, and 11b.

19 **WHEREAS** in Order No. P.P. 48(2022) the Board suspended maximum price adjustments for  
20 gasoline motor fuel in Zones 10, 11 and 11b effective June 30, 2022; and  
21

22 **WHEREAS** delivery information provided to the Board by suppliers to the region shows that  
23 resupply of gasoline motor fuel that is used to supply Zones 10, 11, and 11b has occurred and,  
24 as a result, the Board is satisfied that it is reasonable to lift the suspension of maximum price  
25 adjustments for gasoline motor fuel in these zones to allow for the implementation of new  
26 benchmark prices for gasoline motor fuel, effective August 25, 2022; and

28 **WHEREAS** the Board is also satisfied that the suspension of maximum price adjustments for  
29 gasoline motor fuel should be implemented effective 12:01 am August 25, 2022 until further  
30 resupply of gasoline motor fuel in Zones 10, 11 and 11b.


1. The suspension of maximum price adjustments for gasoline motor fuel implemented pursuant to Order No. P.P. 48(2022) is lifted in Zones 10, 11 and 11b effective 12:01 a.m. August 25, 2022.
2. Maximum price adjustments for gasoline motor fuel in Zones 10, 11 and 11b shall be suspended as of the scheduled maximum price adjustment effective 12:01 a.m. August 25, 2022, until further order of the Board.
