# **Weekly Adjustment of Maximum Prices of Regulated Petroleum Products** *Maximum Price Adjustments for Zones 10, 11, 11a, 11b, 12 and 14*

Effective 12:01 a.m. Thursday, December 21, 2023, the Public Utilities Board set maximum prices for regulated petroleum products in all areas of the province.

While the Board's next regularly scheduled price adjustment is on Thursday, December 28, 2023, the Board continues to monitor changes in market prices for motor fuels and heating fuels and will adjust maximum prices outside the scheduled adjustment as appropriate.

The changes to maximum fuel prices, except for gasoline and diesel motor fuels and stove oil heating fuel in Zones 10, 11, 11a, 11b, 12 and 14, are as follows:

- all types of gasoline motor fuel will increase by up to 1.1 cents per litre (cpl);
- diesel motor fuel on the Island will increase by up to 0.4 cpl;
- diesel motor fuel in Zones 13 and 13a will increase by 0.3 cpl;
- furnace oil heating fuel will increase by 0.45 cpl;
- stove oil heating fuel on the Island will increase by 1.10 cpl;
- stove oil heating fuel in Zones 13 and 13a will increase by 0.54 cpl; and,
- propane heating fuel will decrease by 0.6 cpl.

These changes to maximum prices reflect recent changes in market commodity prices. More information about how maximum prices are set, including a full breakdown by pricing zone, can be found on the Board's website <u>here.</u>

## Maximum Price Adjustments for Labrador Zones 10, 11, 11a, 11b, 12 and 14

#### **Recent Deliveries**

To better reflect the cost of supply given recent deliveries, there will be adjustments to maximum prices for gasoline and diesel motor fuels and stove oil heating fuel in Zone 10 (Labrador – The Straits to Red Bay); Zone 11 (Labrador South – Lodge Bay/Cartwright); and, Zone 11b (Coastal Labrador South – Drum Delivery) effective December 21, 2023.

## Adjustments Related to the Federal Clean Fuel Regulations

Carbon Price Adjustments were implemented on the Island portion of the province and in Zones 13 and 13a in July 2023. Effective with this price adjustment the Board has implemented a Carbon Price Adjustment, on an interim basis, in its calculation of maximum prices for gasoline and diesel motor fuels in Zones 10, 11, 11a, 11b, 12 and 14. The Carbon Price Adjustments are to reflect the

additional costs being incurred by suppliers associated with the carbon intensity reduction requirements of the federal Clean Fuel Regulations. There is no Carbon Price Adjustment for heating fuels as the carbon intensity reduction requirements of the federal Clean Fuel Regulations do not apply to heating fuels at this time. The Board expects that further changes may be made to the Carbon Price Adjustments as market conditions continue to develop under the new federal Clean Fuel Regulations and more information becomes available.

The impact of the changes to retail maximum prices of the recent deliveries and the Carbon Price Adjustment in Zones 10, 11, 11a, 11b, 12 and 14 is set out below:
