## Re: Newfoundland and Labrador Hydro – Amended General Rate Application – Prudence Review – Intevenor Status

On February 27, 2015 the Board invited the intervenors in Hydro's 2014 Supplementary Capital Budget Application relating to the 100 MW combustion turbine generator to apply for limited intervenor status in Hydro's Amended General Rate Application to participate in issues related to the prudence review only.

On March 3, 2015 the Board received an intervenor submission from Mr. Danny Dumaresque indicating his intention to participate in the proceeding relating to the prudence review established by the Board. While the Board did not issue a formal order granting intervenor status to Mr. Dumaresque, Mr. Dumaresque has participated to date in the prudence review and the Board formalizes his status as an intervenor in the prudence review.

On March 6, 2015 the Board received an intervenor submission from Grand Riverkeeper Labrador, Inc. On August 5, 2015 Grand Riverkeeper Labrador Inc. advised the Board that it did not intend to participate further in the proceeding. The Board confirms that Grand Riverkeeper Labrador, Inc. does not require intervenor status in the prudence review.

The remaining schedule for the prudence review has been circulated to all parties and the hearing relating to the issues in the prudence review has tentatively been scheduled to begin on Monday, November 2, 2015.
