

# **Newfoundland Labrador Hydro (NLH)** Supply and Demand Status Report Filed Thursday, November 15, 2018





## Supply Notes For November 14, 2018

- As of 2017 hours, November 03, 2018, Holyrood Unit 1 unavailable due to planned outage 40 MW (170 MW).
- As of 0729 hours, November 09, 2018, Stephenville Gas Turbine available at 25 MW (50 MW).
  - At 1654 hours, November 14, 2018, Bay d'Espoir Unit 6 unavailable (76.5 MW).
- At 1916 hours, November 14, 2018, Hardwoods Gas Turbine unavailable (50 MW).
  - At 1948 hours, November 14, 2018, Hardwoods Gas Turbine available (50 MW).
- At 2058 hours, November 14, 2018, Bay d'Espoir Unit 6 available (76.5 MW).

# **Supply Notes For November 15, 2018**

- 1. Generation outages for running and corrective maintenance are included. These are not unusual for power system operations. They generally do not impact customer supply. The power system operators schedule outages to system equipment whenever possible to coincide with periods when customer demands are low and sufficient supply reserves are available. However, from time to time equipment outages are necessary and reserves may be impacted.
- 2. Due to the Island system having no synchronous connections to the larger North American grid, when there is a sudden loss of large generating units there may be a requirement for some customer's load to be interrupted for short periods to bring generation output equal to customer demand. This automatic action of power system protection, referred to as under frequency load shedding (UFLS), is necessary to ensure the integrity and reliability of system equipment. Under frequency events have typically occurred 5 to 8 times per year on the Island Interconnected System and the resultant customer load interruptions are generally less than 30 minutes. With the activation of the Maritime Link frequency controller during the winter of 2018, UFLS events have occurred less frequently.
- 3. As of 0800 Hours.
- 4. Gross output including station service at Holyrood (24.5 MW) and improved NLH hydraulic output due to water levels (35 MW).

- 6. NLH Island Power Purchases include: CBPP Co-Gen, Nalcor Exploits, Rattle Brook, Star Lake, Wind Generation and capacity assistance (when applicable).
