

Island Supply Notes For August 29, 2025

- A As of 0800 hours, March 30, 2025, Holyrood Unit 3 unavailable due to planned outage 130 MW (150 MW).
- As of 0823 hours, March 31, 2025, Bay d'Espoir Unit 1 unavailable due to planned outage (76.5 MW).
- As of 0823 hours, March 31, 2025, Bay d'Espoir Unit 2 unavailable due to planned outage (76.5 MW).
- As of 0800 hours, May 04, 2025, Holyrood Unit 1 unavailable due to planned outage (170 MW).
- As of 0800 hours, June 08, 2025, Holyrood Unit 2 unavailable due to planned outage (176 MW).
- As of 1400 hours, June 29, 2025, St. Anthony Diesel Plant available at 7.7 MW due to forced derating (9.7 MW).
- As of 0549 hours, July 24, 2025, Cat Arm Unit 1 unavailable due to planned outage (67 MW).
- H As of 1258 hours, August 26, 2025, Holyrood Diesels unavailable due to planned outage (10 MW).
- As of 1439 hours, August 27, 2025, Upper Salmon Unit unavailable due to planned outage (84 MW).

Island Supply Notes For August 30, 2025

1. Generation outages for running and corrective maintenance are included. These are not unusual for power system operations. They generally do not impact customer supply. Hydro schedules outages to system equipment whenever possible to coincide with periods when customer demands are low and sufficient supply reserves are available. However, from time to time equipment outages are necessary and reserves may be impacted.
