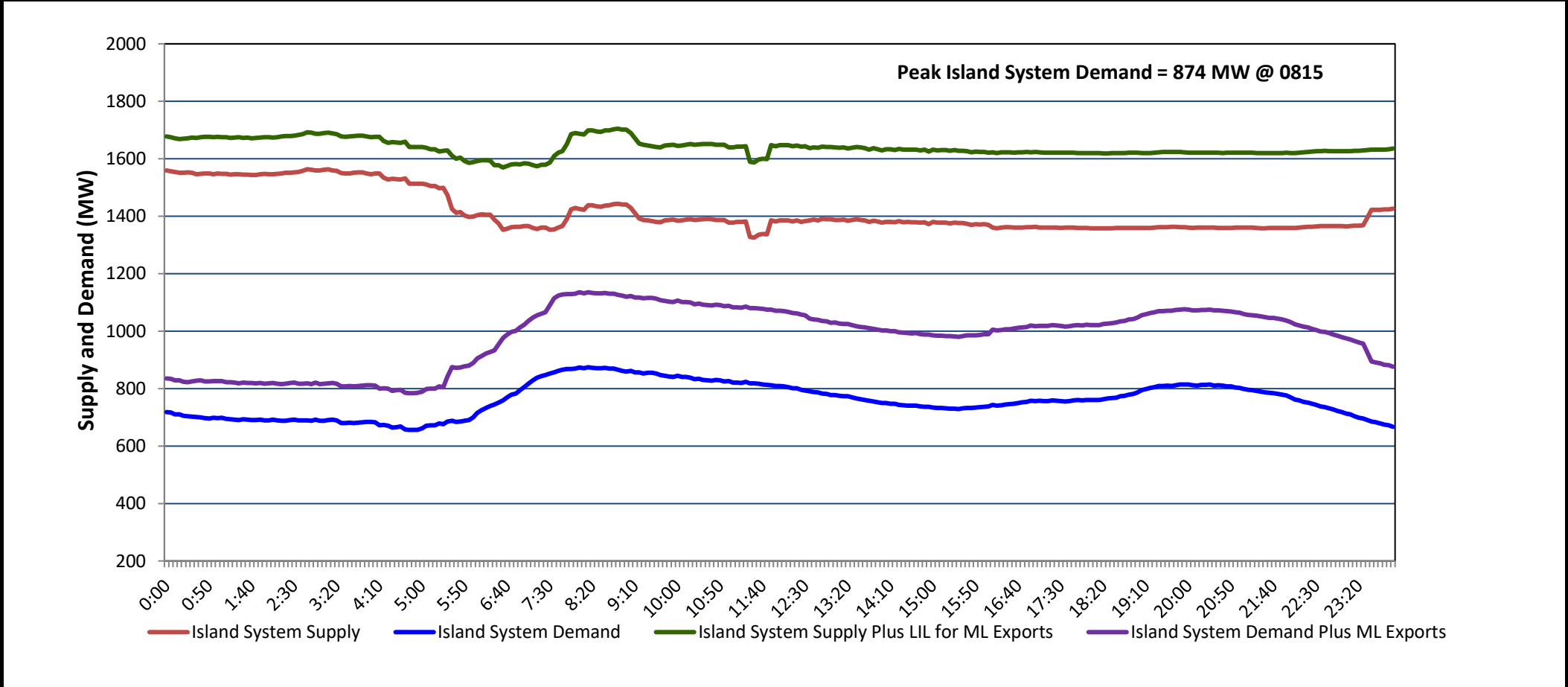

Island Supply Notes For October 02, 2025 ¹	
A	As of 0800 hours, March 30, 2025, Holyrood Unit 3 unavailable due to planned outage 130 MW (150 MW).
B	As of 0823 hours, March 31, 2025, Bay d'Espoir Unit 1 unavailable due to planned outage (76.5 MW).
C	As of 0823 hours, March 31, 2025, Bay d'Espoir Unit 2 unavailable due to planned outage (76.5 MW).
D	As of 2000 hours, September 13, 2025, Holyrood Unit 2 unavailable due to forced extension to planned outage 115 MW (170 MW).
E	As of 1312 hours, September 17, 2025, St. Anthony Diesel Plant unavailable due to a planned outage (9.7 MW).
F	As of 1823 hours, September 26, 2025, Holyrood Unit 1 available at 100 MW due to forced derating (170 MW).
G	As of 1535 hours, September 30, 2025, Labrador Island Link available at 450 MW due to a planned derating (700 MW) - Monopole.
H	At 1100 hours, October 02, 2025, Paradise River Unit unavailable due to planned outage (8 MW).
I	At 1122 hours, October 02, 2025, Hardwoods Gas Turbine unavailable due to forced outage (50 MW).
J	At 1131 hours, October 02, 2025, Paradise River Unit available (8 MW).
K	At 1148 hours, October 02, 2025, Hardwoods Gas Turbine available (50 MW).

Island Supply Notes For October 03, 2025

Notes:	1. Generation outages for running and corrective maintenance are included. These are not unusual for power system operations. They generally do not impact customer supply. Hydro schedules outages to system equipment whenever possible to coincide with periods when customer demands are low and sufficient supply reserves are available. However, from time to time equipment outages are necessary and reserves may be impacted.

	5. NLH Island Power Purchases include: ML Imports, Exploits Generation, Rattle Brook, Star Lake, Wind Generation and capacity assistance (when applicable).

	7. Due to limitations inherent in the design of combustion turbines, the output of combustion turbines may be reduced in the event that ambient temperatures exceed the threshold required for full rated output. This threshold is dependent on the design of each turbine.
