

Island Supply Notes For November 01, 2025

- A As of 0800 hours, March 30, 2025, Holyrood Unit 3 unavailable due to planned outage 130 MW (150 MW).
- As of 0823 hours, March 31, 2025, Bay d'Espoir Unit 1 unavailable due to planned outage (76.5 MW).
- As of 0823 hours, March 31, 2025, Bay d'Espoir Unit 2 unavailable due to planned outage (76.5 MW).
- As of 1502 hours, October 09, 2025, Holyrood Unit 1 available at 100 MW due to forced derating (170 MW).
- E As of 1405 hours, October 23, 2025, Holyrood Unit 2 available at 163 MW due to forced derating (170 MW).
- As of 1600 hours, October 27, 2025, Holyrood Gas Turbine unavailable due to forced outage (123.5 MW).

At 1320 hours, November 01, 2025, St. Anthony Diesel Plant available at 5.7 MW due to forced derating (9.7 MW)

Island Supply Notes For November 02, 2025

Notes: 1. Generation outages for running and corrective maintenance are included. These are not unusual for power system operations. They generally do not impact customer supply. Hydro schedules outages to system equipment whenever possible to coincide with periods when customer demands are low and sufficient supply reserves are available. However, from time to time equipment outages are necessary and reserves may be impacted.

- 3. Gross continuous unit output.
- 4. Gross output from all Island sources (including Note 3).
- 5. NLH Island Power Purchases include: ML Imports, Exploits Generation, Rattle Brook, Star Lake, Wind Generation and capacity assistance (when applicable).
