

Island Supply Notes For November 22, 2025

- A As of 0800 hours, March 30, 2025, Holyrood Unit 3 unavailable due to planned outage 130 MW (150 MW).
- As of 0823 hours, March 31, 2025, Bay d'Espoir Unit 1 unavailable due to planned outage (76.5 MW).
- As of 0823 hours, March 31, 2025, Bay d'Espoir Unit 2 unavailable due to planned outage (76.5 MW).
- As of 0046 hours, November 02, 2025, Buy a Espon only 2 anavailable due to planned outage (75.5 MW)
- As of 0846 hours, November 02, 2025, Hinds Lake Unit unavailable due to planned outage (75 MW).
- E As of 1400 hours, November 04, 2025, St. Anthony Diesel Plant available at 7.7 MW due to forced derating (9.7 MW).
- As of 0817 hours, November 14, 2025, Bay d'Espoir Unit 5 unavailable due to planned outage (76.5 MW).
- G As of 0817 hours, November 14, 2025, Bay d'Espoir Unit 6 unavailable due to planned outage (76.5 MW).
- As of 1115 hours, November 17, 2025, Holyrood Unit 1 available at 100 MW due to forced derating (170 MW).
- As of 1423 hours, November 20, 2025, Hardwoods Gas Turbine available at 25 MW due to forced derating (50 MW).

Island Supply Notes For November 23, 2025

1. Generation outages for running and corrective maintenance are included. These are not unusual for power system operations. They generally do not impact customer supply. Hydro schedules outages to system equipment whenever possible to coincide with periods when customer demands are low and sufficient supply reserves are available. However, from time to time equipment outages are necessary and reserves may be impacted.
