The outage occurred as a result of a downed primary conductor during severe weather. No customers lost electrical service as a result of this transmission line outage.
20 21 22 23 24 25 26 27		The outage to 39L between Springfield and Bay Roberts on January 5 th , 2014 was required to replace a breaker at the Bay Roberts substation. The breaker was replaced and the line restored to service on January 9 th , 2014. The outage to 72L between Hardwoods and Goulds on January 9 th , 2014 was required to allow technical staff to inspect a breaker. The outage to 48L between Bay Roberts and Blaketown on January 10 th , 2014 was required to repair a breaker closing mechanism. No customers lost electrical service as a result of any of these transmission line outages.
28 29 30 31 32 33 34 35		A 138kV-66kV transformer located at Newfoundland Power's Blaketown substation and transmission line 41L between Carbonear and Heart's Content are currently available but out of service. These assets have been out of service since January 8 th , 2014. They were taken out of service to reduce the loading on Newfoundland and Labrador Hydro's ("Hydro") Western Avalon substation transformers. These Newfoundland Power assets are available and can be returned to service as soon as Hydro has resolved its transformation capacity limitations at the Western Avalon substation.
35 36 37		All of Newfoundland Power's other transmission assets were available on January 24 th , 2014, and remain available as of February 3 rd , 2014.

¹ The fault also caused and outage to transmission line 43L between Heart's Content and New Chelsea.

² 65L was repaired within 8 hours but the Company was unable to reinstate service to customers immediately upon completion of repairs due to insufficient available electricity supply. Not all 2,600 customers were without service for the almost 12 ¹/₂ hour duration of this transmission outage; Newfoundland Power was able to reinstate service to approximately 900 customers within 3 hours of the outage.
