Re: Investigation and Hearing into Supply Issues and Power Outages on the Island Interconnected System – Winter Readiness Planning Report – Status Updates


Hydro's report entitled *A Report to the Board of Commissioners of Public Utilities Regarding 2015-16 Winter Readiness Planning*, dated October 1, 2015, has been reviewed and the Board requests status updates to the report, including Appendices, be submitted as follows:

For each asset, group of assets or plant and equipment the updates should report on any notable deviations from the schedules previously reported in the 2015-16 Winter Readiness Planning Report, setting out the extent of and reasons for any deviation as well as any changes to expected completion dates. The updates to the Appendices should include all previously listed activities or items, indicating clearly those completed or acquired since the last report or update, and those activities or items still outstanding.
