Re: Investigation and Hearing into Supply Issues and Power Outages on the Island Interconnected System — Phase Two - Outstanding Requests for Information (RFI) Responses NP-NLH-005 and NP-NLH-018

On May 8, 2015 the Board issued Order No. P.U. 13(2015) requiring Hydro to file responses to requests for information NP-NLH-005 and NP-NLH-018. To date Hydro has not provided responses to the outstanding RFIs and has not indicated when it expects to file these responses.

In its May 19, 2015 letter, Newfoundland Power restated its position that it requires the responses to these RFIs to be reviewed by its expert before issuing second round Phase Two RFIs. This will impact the filing date of June 1, 2015.

The Board asks Hydro to immediately provide the responses to the outstanding requests for information or advise when it anticipates filing the outstanding responses.
