Dear Mr. Young,

The Board acknowledges receipt of your letters of March 25, 2020 and March 27, 2020 which outlined the current implications of the Covid-19 pandemic for the Muskrat Falls Project, including that it is not possible to provide a reliable schedule forecast at this time and that limited work is still continuing with respect to the LIL software development.

The Board requests that Newfoundland and Labrador Hydro provide an updated overall schedule as soon as it is available and that it continue to report on any changes, as they occur, with respect to:

- (i) the schedule for the LIL software development and testing;
- (ii) binding/vibration issues with the Soldiers pond synchronous condensers; and
- (iii) any other matter that may impact the integration of the Muskrat Falls Project to the Island interconnected system.

Regular reporting as previously directed should continue.
