Review – Requests for Information filed by Consumer Advocate on June 30, 2020**

The Board is in receipt of the Requests for Information (RFIs) filed by the Consumer Advocate on June 30, 2020. Please note that the schedule as outlined in the Board's correspondence of June 9, 2020, which stated "requests for information on the information presented at the technical conference and all reports filed to date are to be filed by June 30, 2020", referred to information provided and reports filed by Hydro. At this point in the process, all parties, including Liberty, are still receiving and analyzing information from Hydro. Once Hydro has concluded its presentation of information, which is expected to be November, 2020, all parties will be provided the opportunity to file expert reports and RFIs to the other parties will be scheduled.
