**Re: Newfoundland and Labrador Hydro – Reliability and Resource Adequacy Study  
Review The Liberty Consulting Group Fourteenth Quarterly Monitoring Report on  
the Integration of Power Supply Facilities to the Island Interconnected System - Update**

Since the Board's letter of March 16, 2022, the Board has received a letter from The Liberty Consulting Group ("Liberty") which confirmed their receipt from Newfoundland and Labrador Hydro ("Hydro") of the responses to questions posed on February 14, 2022. Liberty also advised that it did not, at this time, anticipate any amendment to its Fourteenth Quarterly Monitoring Report and that it planned to follow up on a number of the responses at the upcoming quarterly meeting with Hydro.

The Board has determined that, as more up to date information on the status of the Muskrat Falls Project will be received from Hydro in its monthly status report due in early April and in Liberty's next quarterly monitoring report, it will not ask questions of Hydro at this time. Further questions may be directed to Hydro following receipt of Hydro's monthly report and Liberty's Fifteenth Quarterly Transition-to-Operations Monitoring Report.
