Re: Newfoundland and Labrador Hydro – Reliability and Resource Adequacy Study Review – The Liberty Consulting Group Tenth Quarterly Monitoring Report on the Integration of Power Supply Facilities to the Island Interconnected System – Monthly Reporting on Status of Muskrat Falls Project

In its May 19, 2020 report “Tenth Quarterly Monitoring Report on the Integration of Power Supply Facilities to the Island Interconnected System”, Liberty stated the following as a follow up action:

Re-examination of the scope and frequency of monitoring efforts should address whether continuing performance lags (e.g., LIL software and condenser vibration) and the now short-period remaining before the onset of the winter season call for changed focus, scope abbreviation, and frequency of interaction with management and reporting to the Board. Monthly reports may better focus attention on the barriers to completion before the coming winter period.

Given the current situation with COVID 19 and the uncertainty of its impact on construction and maintenance schedules, the Board agrees that monthly reporting on the status of the Muskrat Falls project and to ensure winter preparedness should be implemented. Board staff will contact appropriate Hydro staff to discuss scheduling
