Re: Application for Approval of Capital Expenditures Necessary to Address Supply in Charlottetown and Pinsent's Arm, Labrador – Hydro's Reply

On October 7, 2022, Newfoundland and Labrador Hydro ("Hydro") filed an application with the Board of Commissioners of Public Utilities ("Board") for approval of capital expenditures necessary to address supply in Charlottetown and Pinsent's Arm, Labrador ("Application"). Requests for Information were filed on October 18, 2022, to which Hydro filed its responses on October 24, 2022.

Hydro notes that Newfoundland Power Inc. ("Newfoundland Power") filed correspondence on October 27, 2022. Newfoundland Power advised that, based on the information Hydro had provided, Newfoundland Power does not object to Hydro's Application. Newfoundland Power submitted that in their view, Hydro's recommended alternative is the most appropriate given the circumstances.
