The additional information filed by Hydro on September 11, 2025, in response to Question 11, indicated that the Conservation Demand Management ("CDM") Potential Study undertaken by Posterity Group will be filed in December 2025 as part of the 2026-2030 Joint Utility Energy, Conservation Demand Management Plan. The Board requests that Hydro file the CDM Potential Study immediately if possible so that it can be considered as part of this matter.

The monthly update on the early execution works for the Avalon Gas Turbine for the period ended July, 2025 indicated that the request for proposals for several key pieces of work would close over the summer months. The Board requests that Hydro provide details on the contracts awarded, including but not limited to the supply of combustion turbines which closed on July 4, 2025, in its next monthly update due in October, 2025
