Dr. Booth understands that they are not normally deemed the way they are in 9 Canada, but accepted unless egregious. Note unlike Canada for a long time the US had the Public Utility Holding Company Act of 1935 where the US 10 Securities and Exchange Commission had the authority to regulate, license and 11 break up utility holding companies. The rationale being that US UHCs through 12 pyramiding had only limited equity which exacerbated the effects of the 1929 13 Stock market crash and the Great Depression. Consequently, the concern in the 14 US was to ensure that the operating company actually did have enough equity. 15 16 As far as Dr. Booth is aware no securities regulator in Canada ever had such 17 18 oversight responsibilities or that Canadian regulated utilities did not have enough equity capital. 19
