Further to the above-captioned, this is to acknowledge your correspondence dated August 17, 2023, altering the date set for the requesting of a Technical Conference by the parties from August 25<sup>th</sup> to September 8<sup>th</sup>.

However, now that Newfoundland Power's Request for an extension of time to file their RFIs to August 31<sup>st</sup> has also been granted, the Consumer Advocate submits that this extension necessitates a further change in the schedule regarding the Notice of Intervenor evidence.
