A. Newfoundland Power notes that this Request for Information ("RFI") is substantively identical to RFIs CA-NP-008 and CA-NP-009 filed in relation to Newfoundland Power's 2024 Capital Budget Application and 2025 Capital Budget Application, respectively.

10 11 Public Hearings are held annually on Newfoundland Power's capital budget applications.¹ These hearings have generally proceeded via paper-based processes. While the Company participates in oral hearings of its applications at the direction of the Board, it is settled law that an oral hearing is not required.²

Table 1 lists the dates of all oral hearings that the Board has held on Newfoundland Power's annual capital budget applications since 1994.

The Board published a "Notice of Application" in relation to Newfoundland Power's *2026 Capital Budget Application* on or about July 9, 2025, which included instructions on how "anyone" can participate in the process. The public notice was posted on VOCM and allNewfoundlandLabrador for five (5) business days.

The adequacy of the Board's current procedure for considering utility capital budget applications has been assessed twice in recent years by the Newfoundland and Labrador Court of Appeal. In Consumer Advocate v. Board of Commissioners of Public Utilities, 2021 NLCA 50, the Court of Appeal stated, "There is no requirement for a public hearing under the Public Utilities Act, the Regulations or the Guidelines. It is a matter within the Board's discretion..." Similarly, in Consumer Advocate v. Board of Commissioners of Public Utilities, 2022 NLCA 39, the Court stated, "The statutory scheme does not require an oral hearing. The board has taken an active role in the process, making requests for information, and facilitating the exchange of information among the Consumer Advocate, Newfoundland Power and the Board... In this case, the Board gave comprehensive reasons for choosing a written procedure rather than an oral hearing for the purpose of assessing Newfoundland Power's application. The board is authorized to choose its own process and has expertise in assessing Newfoundland Power's annual capital expenditures budget."
