Re: Newfoundland and Labrador Hydro – Amended General Rate Application – Compliance Application – Order No. P.U. 49(2016) - Industrial Customer RSP – Recovery of Revenue Deficiencies from Industrial Customer Load Variation Component Credit Balance – Request for Comments

Attached please find a copy of correspondence to the Board from the Industrial Customer Group (Corner Brook Pulp and Paper Limited and NARL Refining Limited) dated May 15, 2017 and from Newfoundland and Labrador Hydro dated May 16, 2017.

The correspondence from the Industrial Customer Group outlines an agreement between the Island Industrial Customer Group and Vale Newfoundland and Labrador Limited on the disposition of the balance in the Load Variation account allocated to the Island Industrial customers. Hydro indicates in its correspondence that the agreement would reduce the credit balance available to offset electricity costs of Teck Resources Limited and Praxair Canada Inc. by approximately \$16,000 over time. Hydro also indicates that it does not object to this proposal.
