Metro General Insurance Corporation
to implement revised rates for its
Private Passenger class of business.

WHEREAS, by application received November 28, 2003, Metro General
Insurance Corporation applied to the Board for approval to implement a revised rating
program for its Private Passenger class of business, and

WHEREAS the Board, after due examination and analysis of the proposed rating
program, finds that the filing conforms with the Benchmarks, and should be approved as
filed.

IT IS THEREFORE ORDERED THAT:

1. Order No. A.I. 22 (2003) be and it is hereby rescinded.
2. Approval be and it is hereby granted Metro General Insurance Corporation for the implementation of a revised rating program for its Private passenger class of business with base rates as follows:

iv.	select class	10.0%	third party liability, & collision
v.	renewal	5.0%	third party liability, & collision
vi.	student, away-from-home	50.0%	lowest of class 05 or 06 premiums only
vii.	short commute	23.0%	- third party liability, territory 1
		7.0%	- third party liability, territories 2 & 3
		9.2%	- collision, territory 1
		10.0%	- third party liability, territories 2 & 3

4. The rates established by way of this Order are to be implemented January 1, 2004 for new business and February 1, 2004 for renewals.
