

**M.C. 10 (2003)**

**IN THE MATTER OF THE MOTOR CARRIER ACT,  
CHAPTER M-19, R.S.N. 1990,**

**AND**

**IN THE MATTER OF THE APPLICATION OF  
The Town of Old Perlican  
FOR THE APPROVAL OF AN AMENDMENT OF A  
MOTOR CARRIER CERTIFICATE.**

**WHEREAS** on April 23, 2003 the Town of Old Perlican applied to amend its Motor Carrier Certificate to add certain communities previously served by The Town of Winterton, and

**WHEREAS** on July 28, 2003 the Board issued Order No. M.C. 5 (2003) approving the addition of named communities to Motor Carrier Certificate No. 4010 issued to the Town of Old Perlican, and

**WHEREAS** in correspondence dated June 10, 2003 the Town of Old Perlican notified the Board that it was agreeable to amendments to its Motor Carrier Certificate proposed by the Department of Health and Community Services, namely the deletion of the communities of Job's Cove, Burnt Point, Gull Island, Long Beach and Northern Bay, as these communities were included under Motor Carrier Certificate No. 4026 issued to North Shore Central Ambulance, and

**WHEREAS** on October 14, 2003, North Shore Central Ambulance notified the Board in writing that it was equipped to become the sole service provider to the affected communities and

**WHEREAS** on December 18, 2003 the Board reviewed all information in connection with the amendment to Motor Carrier Certificate No. 4010.

**IT IS THEREFORE ORDERED THAT:**

Motor Carrier Certificate No. 4010 be amended by deleting therefrom the communities of Job's Cove, Burnt Point, Gull Island, Long Beach, and Northern Bay.
