IN THE MATTER OF THE CANCELLATION OF
MOTOR CARRIER CERTIFICATE NO. 4013
ISSUED TO THE ROYAL CANADIAN LEGION AMBULANCE SERVICE,
HARBOUR GRACE

WHEREAS on July 2, 1996 the Royal Canadian Legion, Harbour Grace, advised the Board of its intention to discontinue the provision of ambulance services pursuant to Motor Carrier Certificate No. 4013 as of July 31, 1996, and

WHEREAS on July 9, 1996, the Board was advised by the Department of Health that it was in the process of negotiating with the Royal Canadian Legion, Harbour Grace, to continue the provision of ambulance services, and

WHEREAS, on February 3, 1999, Motor Registration Division of the Department of Government Services and Lands advised the Board that the Royal Canadian Legion Ambulance Service, Harbour Grace, had not registered an ambulance vehicle capable of providing the services for a period in excess of three years, and

WHEREAS on February 9, 1999, Royal Canadian Legion Ambulance Service, Harbour Grace, was written requesting confirmation as to whether or not it intended to relinquish Motor Carrier Certificate No. 4013, and

WHEREAS nothing further was heard from the Royal Canadian Legion Ambulance Service, Harbour Grace, and

WHEREAS on February 15, 2002, staff of the Board became aware that the Certificate issued in the name of the Royal Canadian Legion Ambulance Service, Harbour Grace, remained in existence, and

WHEREAS on March 6, 2002, the Royal Canadian Legion Ambulance Service, Harbour Grace, was written by Registered Mail advising of the Board's intention to cancel the Motor Carrier Certificate issued January 24, 1978, and that the Legion was, pursuant to the Motor Carrier Act, provided with fifteen days notice within which time they might file a request for a hearing to state their reasons before the Board as to why the Certificate should not be cancelled, and

WHEREAS following fifteen clear days notice, the Board did not receive a request from the Royal Canadian Legion Ambulance Service, Harbour Grace, to conduct a hearing, and

WHEREAS at a meeting of the Board held Thursday, May 2, 2002, the matter of the cancellation of the Certificate was dealt with.

IT IS THEREFORE ORDERED THAT:

Motor Carrier Certificate No. 4013, issued January 24, 1978, to Royal Canadian Legion Ambulance Service, Harbour Grace, be and is hereby cancelled with effect from May 2, 2002, and said Motor Carrier Certificate No. 4013 together with all Schedules attached thereto be returned to the Board.
